Enclosed are your tax statements(s) for the year 2015. **My preference is that you pay your taxes by mail.** Please enclose the correct stub with payment. **Payment should be in the form of a check. NO CASH** will be accepted. The First Tax payment is **payable to Town of Herman**. Mail to: **Kathy Twardokus, N5952 Pierce Rd, Mayville, WI 53050** postmarked by Jan. 31, 2016. **Enclose a stamped self-addressed business size envelope for return receipts and dog licenses.** Mortgage Company checks made out to property owners **and** the Town of Herman must be endorsed by **ALL** payees prior to payment to the Town. **The second tax installment is payable to Dodge Co. Treasurer, 127 East Oak St, Juneau, WI 53039-1390** postmarked by July 31, 2016. For a receipt, send the county a SASE, also.

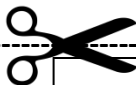

If you did not receive a lottery credit and feel you are eligible for it, contact the Town or County Treasurer. Lottery Credit is applied to tax bills based on primary residency as of January 1, 2015 per guidelines of the State of WI. All parcels with improvements receive a First Dollar Credit.

The Twardokus' have installed a locked mailbox in their driveway with a slot to drop tax payments through. The box is by the house with a drive up feature to be reached from your car.

For your information

- Voting will be at Herman School for February and April. Watch for notices as the voting location may change due to Herman School closing. Polls open 7:00am - 8:00pm
- A Land Use Permit must be obtained from Zoning Administrator Larry Greuel (262-224-3161) before any new construction, building additions or structural changes to existing buildings can be done.
- Any stray, lost or nuisance dogs will be picked up by Dog Catcher, Tim Mader (920-296-5618). Payment is \$50 for each call along with a \$5 per day boarding fee and any other expenses. Payment is required before dog is returned.
- All dogs over 5 months need to be licensed. Share this information with residents who rent and don't see this notice.
- When you register vehicles with the Dept of Motor Vehicles, make sure you indicate the vehicle is kept in Town of Herman, not the village or city of your post office. It affects town revenues and taxes.
- Town Board Meetings are held at Herman School on the Second Tuesday of the month at 7:00pm. Changes to meeting dates and times will be posted. Agendas are posted at Lisko's Tavern, Hillcrest Inn, Woodland Hardware, Town Hall and the Town's website: www.townofherman.com
- The Recycling Center is open Saturdays 9am - 1:15pm. List of fees are: 30 Gal Bag-\$1.00; 50 Gal Bag-\$2.00; Tires-\$2.00; Large truck tires-\$6.00; Tractor tires-\$25.00; Pickup Load-\$20. Large items like mattresses, chairs, couches, carpeting etc.-\$5.00. The third Saturday in April and October a large dumpster is at the recycling center for disposal of these larger type items.
- Appliances : Stoves, washers and dryers are accepted
- Refrigerators, TVs, microwaves, freezers and electronics **WILL NOT BE ACCEPTED**. Take to a Recycle Salvage Yard.

The town has created a Code of Ordinances that is available via our website. The Code combines all of the Town's local ordinances into one document.

Earlier this year, we contracted with Independent Inspections, Ltd. to perform all building inspections for the town. Permits are required from the Zoning Administrator, Larry Greuel at 262-224-3161. A fee schedule was established for new and remodel construction.

Our roads remain the single largest expense for the town. It is becoming increasingly difficult to properly maintain our roadways due to increased cost of labor and materials associated with repair and/or re-construction.

As part of our road maintenance, we hired a contractor to complete roadside brushing in the road right-of-way on some of our roads. To help keep our roads safe, please consider removing brush and overgrown trees on your property that are within the road right-of-way. Right-of-way varies from road to road, however typically 33 feet from the center of road to either side is considered the right-of-way.

You are responsible for your own driveway. Emergency response vehicles require a path at least 20 feet wide and 10 feet high to enter your property. Please evaluate your property and remove trees and brush that may interfere with emergency response vehicles.

With the eventual closure of Herman School, we may need to find an alternate site to hold town meetings and elections. Our current town hall is not equipped for meetings or elections. Watch our website for additional information in the coming months.

A reminder: Junk and Unlicensed vehicles are not allowed on any property unless inside a building.
